2010 LEAGUE MEMBERSHIP APPLICATION FORM

The USGA Handicap System defines a golf league as, "an organization of at least 10 individual members that operates under bylaws with committees (including a Handicap Committee) to supervise golf activities, provide peer review, and maintain the integrity of the USGA Handicap System. Members of a golf league must have a reasonable opportunity to play golf with each other. They must be able to return scores personally, and these scores must be available for review by fellow league members."

The MWPGA Bylaws require that "application for membership renewal must be made and the annual dues paid by December 31 of the year prior to the coming season. Dues paid after December 31 will be assessed a late fee. To be eligible for any competitions, the completed application, dues and late fees must be received by the Association before April 15 of the current year."

If dues are not paid by December 31, 2009, your league's membership will lapse and a late fee of \$10, in addition to the annual dues of \$60, will be required in order to reactivate membership.

Receipt of applications and dues from LEAGUES will be accepted until April 15, 2010.
